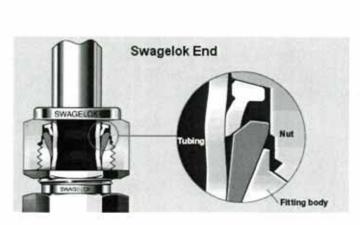

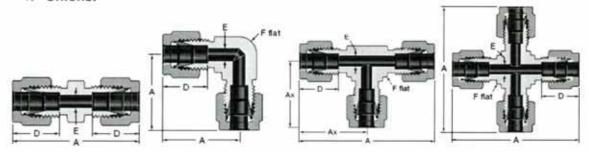

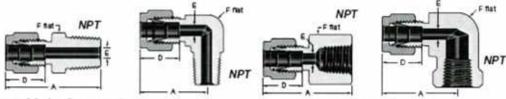


Configurations
